3. HAZARDS IDENTIFICATION

POTENTIAL ACUTE HEALTH EFFECTS:

<u>EYE CONTACT</u>: May cause moderate eye irritation. Eye irritation signs and symptoms may include a burning sensation, redness, swelling and/or blurred vision.

<u>SKIN CONTACT</u>: May cause moderate skin irritation. Repeated exposure may cause skin dryness or cracking. Skin irritation signs and symptoms may include a burning sensation, redness, swelling and blisters.

<u>INHALATION</u>: Vapours expected to be slightly irritating. Respiratory irritation signs and symptoms may include a temporary burning sensation of the nose and throat, coughing, and/or difficulty breathing.

4. FIRST AID MEASURES

<u>EYE CONTACT</u>: Flush eyes with water for at least 15 minutes while holding eyelids open. If irritation or redness persists or signs of toxicity occur, seek medical attention.

<u>SKIN CONTACT</u>: Remove from source of exposure. Flush with copious amounts of water. If irritation persists or signs of toxicity occur, seeks medical attention.

<u>INHALATION</u>: Remove person to fresh air. If not breathing, give artificial respiration. If breathing is difficult, get immediate medical attention.

<u>INGESTION</u>: DO NOT induce vomiting. Never give anything by mouth to an unconscious or convulsing person. Seek immediate medical attention. If vomiting occurs spontaneously, keep head below hips to prevent aspiration of liquid into the lungs.

<u>NOTES TO PHYSICIAN</u>: Dermatitis may result from prolonged or repeated exposure. Potential for chemical pneumonitis. Could cause central nervous system depression. Consider: gastric lavage with protection airway, administration of activated charcoal.

EXTINGUISHING MEDIA: Use DRY chemicals, CO2, alchol foam or water spray.

<u>SPECIAL EXPOSURE HAZARDS</u>: Carbon monoxide may be evolved if incomplete combustion occurs. Product will float and can be reignited on surface of water. Vapors are heavier than air and may accumulate in low areas. Vapors may travel along the ground to be ignited at distant locations. NEVER use a water jet directly on the fire because it may spread the fire to a larger area. Use fine water spray or fog to control fire spread and cool adjacent structure or containers. HAZARDOUS DECOMPOSITION/COMBUSTION MATERIALS (under fire conditions): Carbon oxides and traces of incompletely burned carbon compounds, Silicon dioxide.

<u>SPECIAL PROTECTIVE EQUIPMENT</u>: Fire fighters should wear full protective clothing, including self-contained breathing equipment.

6. ACCIDENTAL RELEASE MEASURES

<u>PERSONAL PRECAUTIONARY MEASURES</u>: Wear appropriate protective equipment. <u>ENVIRONMENTAL PRECAUTIONARY MEASURES</u>: Prevent entry into sewers or streams. Consult local authorities.

<u>PROCEDURE FOR CLEAN UP</u>: (Industrial Use) Isolate hazard area and restrict access. Stop leak only if safe to do so. Remove ignition sources and work with non-sparking tools. Small spills: soak up with absorbent material and scoop into containers. Large spills: prevent contamination of waterways. Pump into suitable container. Clean up residual with absorbent material and flush with water. Take precautionary measures against static discharge. Clean area as appropriate, some material even in small quantities may present a slip hazard. Observe all personal protection equipment recommendations described in Sections 5 and 8. Ensure electrical continuity by bonding/grounding all equipment. Monitor area with combustible gas indicator.

7. HANDLING AND STORAGE

STORAGE:

Store in a cool, dry, well ventilated area, away from heat and ignition sources. Place away from incompatible materials. Store in accordance with good industrial practices.
